## BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF THE COU

"AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2019-08, THE 2020 ANNUAL BUDGET, GRANT COUNTY ARKANSAS IN ORDER TO MAKE ADDITIONAL APPROPRIATIONS AND CORRECTIONS."

WHEREAS, during implementation it has been determined there were some classification errors in the "2020 Annual Budget, Grant County Arkansas"; and

WHEREAS, it is the desire of this Court that errors and omissions be corrected in order to establish an accurate budget.

NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF GRANT COUNTY.

**Section 1.** <u>Amendments.</u> Ordinance No. 2019-08 the 2020 Annual Budget, Grant County Arkansas is hereby amended per the following numerations.

**Section 1A.** To correct a classification error in County General - Tax Collector add an appropriation for Other Miscellaneous 1000-0104-3100 of \$1,000.00 and remove the \$1,000.00 appropriation for Other Supplies 1000-0104-2011.

Section 1B. To correct classification errors in Grant County Rescue Fund, add an appropriation for Utilities - Gas 3400-0504-3061 of \$825.00, decrease the appropriation for Utilities -Water 3400-0504-3062 by \$425.00 to reflect a total appropriation of \$400.00 and remove the \$400.00 appropriation for Utilities - Waste Disposal 3400-0504-3063; add an appropriation for Note Principal 3400-0504-5003 of \$2,607.52 and remove the \$2,607.52 appropriation for Lease Purchase Principal 3400-0504-5005; add an appropriation for Note Interest 3400-0504-5004 of \$644.12 and remove the \$644.12 appropriation for Lease Purchase Interest 3400-0504-5006.

**Section 2.** Purpose. This Ordinance shall constitute new appropriations and corrections for the purposes specified for the calendar year 2020 subject only to revision or modification by the Quorum Court.

**Section 3.** <u>Severability.</u> If any provision of the Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provision or applications of the Ordinance which can be given effect without the invalid provisions or applications, and to this end, the provisions of this Ordinance are declared to be severable.

**Section 4.** Effective Date. This Ordinance being necessary for the protection and preservation of public health and safety, an emergency is hereby declared to exist, and this Ordinance shall be in force and shall take effect upon passage and approval.
