AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2020-11, THE 2021 ANNUAL BUDGET, GRANT COUNTY ARKANSAS.

WHEREAS, Grant County received a \$15,000.00 grant for work at Cox Creek Lake Park from the State of Arkansas and;

WHEREAS, there is a need for some remodel work to be done on the interior of the courthouse that could be paid out of the Coronavirus Relief Fund; and

WHEREAS, The President of the United States signed the American Rescue Plan Act on March 11, 2021 and this Act provided funds for Grant County in the amount of \$3,547,762.00 with one half of the amount being receipted on June 2, 2021; and

WHEREAS, there are projects that can utilize the money received from the American Rescue Plan.

THEREFORE, this Court amends the 2021 budget for said purpose.

Section 1. Budget Amendment.

This amendment to the 2021 Annual Budget, Grant County Arkansas appropriates the following expenditures:

County General Fund 1000

Cox Creek Lake Park – Capital Outlay, Improvements Other Than Buildings
expenditure code 1000-0603-4003 \$15,000.00.

Coronavirus Relief Fund 1005

Building Materials & Repairs expenditure code 1005-100-2020 \$30,000.00

American Rescue Plan Fund 3046

Capital Outlay, Improvements Other Than Buildings
expenditure code 3046-0100-4003 \$50,000.00.

Section 2. Purpose. This Ordinance shall constitute new appropriations for the purposes specified for the calendar year 2021 subject only to revision or modification by the Quorum Court.

Section 3. Revenues. This Ordinance shall also reflect unanticipated revenues of \$15,000.00 for the County General Fund and \$1,773,881.00 for the American Rescue Plan Fund in the 2021 Annual Budget, Grant County Arkansas.

Section 4. Severability. If any provision of the Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provision or applications of the Ordinance which can be given effect without the invalid provisions or applications, and to this end, the provisions of this Ordinance are declared to be severable.

Section 5. Effective Date. This Ordinance shall be in force and shall take effect upon passage and approval.
