**AN ORDINANCE TO ESTABLISH PREMIUM PAY AND TO AMEND  
THE ORIGINAL APPROPRIATION ORDINANCE 2020-11, THE  
2021 ANNUAL BUDGET, GRANT COUNTY ARKANSAS.**

**WHEREAS**, the American Rescue Plan, Public Law No. 117-2 (March 11, 2021), was adopted into law and provided States, Cities, Counties and Tribal Governments funds for the purpose of addressing the various adverse impacts of COVID-19 upon these governmental units and society, including premium pay for essential workers defined by Interim Final Rule definitions in pertinent part, as any work performed by a County employee involving regular in-person interactions or regular physical handling of items that were also handled by others; and

**WHEREAS**, 31 C.F.R. Part 35 the US Treasury Interim Final Rule, sets forth the authority and need for providing premium pay to assure the retention and support for essential workers and public functions; and

**WHEREAS**, the Quorum Court of Grant County, AR, recognizes the need to provide resilience to our local government and provide premium pay back to March 7, 2020, to County employees as authorized by the American Rescue Plan and guidance by the United States Treasury;

**NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF GRANT  
COUNTY, ARKANSAS**

**SECTION 1.** That it hereby approves premium pay for eligible current County employees continuously employed by Grant County for any of the period of March 7, 2020, to March 6, 2021.

**SECTION 2.** Each eligible Grant County employee, currently employed, shall be provided the additional payment of two dollars and fifty cents (\$2.50) per hour worked during the described work period, with deductions as required by 31 CFR Part 35 the US Treasury Interim Final Rule, from which all applicable payroll deductions shall be deducted.

**SECTION 3.** Each eligible Grant County poll worker shall be provided the additional payment of five dollars (\$5.00) per hour worked during the described work period, with deductions as required by 31 CFR Part 35 the US Treasury Interim Final Rule, from which all applicable payroll deductions shall be deducted.

**SECTION 4.** That it hereby adopts a newly revised Per Diem Rate for Justice of the Peace set at \$600.00 per meeting attended for the calendar year 2021 and said rate shall be retroactive to January 1, 2021.

**SECTION 5.** Ordinance No. 2020-11, the "2021 Annual Budget, Grant County Arkansas", is hereby amended and the respective sums shall be expended from the appropriate General Ledger of the newly added Fund #3046, the American Rescue Plan Fund; and allocated to the following expenditure codes in the amount set forth in the attachment hereby adopted by reference and so titled "Premium Pay Appropriation".

**SECTION 6.** If any of the provisions of this ordinance or the application thereof to any person or circumstances shall be held invalid, such invalidity shall not affect the other provisions or application, and to this end, the provisions of this Ordinance are declared severable.


**SECTION 7.** This Ordinance shall be in force and shall take effect upon passage and approval.
