ORDINANCE- 21-7

AN ORDINANCE AUTHORIZING THE CONTINUATION OF DOING BUSINESS WITH CERTAIN ESTABLISHED BUSINESSES WITHIN THE CITY LIMITS OF THE CITY OF SHERIDAN WHICH ARE OWNED OR CO-OWNED OR OF SPECIAL INTEREST TO CERTAIN CITY EMPLOYEES.

WHEREAS, the City of Sheridan and the Sheridan City Council has always encouraged local residents to do business with our local businesses whenever possible, and

WHEREAS, in setting this example the City of Sheridan has always traded with local businesses whenever possible, and

Max Polk, owner of "Max's Garage and Wrecker Service" has served on the Sheridan Fire Department for many years, has now retired from the Sheridan Fire Department but continues to be instrumental in making necessary repairs on Fire Fighting Equipment, City Dump Trucks and Sanitation Equipment, Police Vehicles and certain vehicles used by other departments, and the Sheridan City Council appreciates the services of his business and by reference of this ordinance approves the continuation of his services within all departments of the City of Sheridan, and

Jim Lancaster and David Damron hold certain" Administrative Positions" with Peoples Bank of Sheridan. Sheridan is very fortunate to have Peoples Bank as well as other banks and financial institutions within our city limits and the Sheridan City Council appreciates the services rendered by those institutions and by reference of this ordinance approves the continuation of doing business with Peoples Bank, and

Clerk/ Treasurer, Carrie Smith is co-owner of "Koon's Jewelry". Occasionally, the City Council authorizes a plaque or clock to be purchased, to be awarded upon retirement, special recognition or something of this nature for employee's or officers of the city. The City Council appreciates the services of this business in the past and by reference of this ordinance, approves the continuation of such business.

Bryan Williams, spouse of Melanie Williams who is employed by the Sheridan Detention Center, is owner and operator of "SAMSON AUTOWORKS, Mobile Service". Bryan Williams occasionally, will perform minor vehicle maintenance on Police Dept. and/or Detention Facility vehicles. The Sheridan City Council appreciates the services of this business in the past and by reference of this ordinance, approves the continuation of such business.

SECTION 1. the Sheridan City Council hereby authorizes the continuation of the various departments of the city to continue transacting business with the aforementioned businesses.

SECTION 2. It shall continue to be the individual Department Supervisor's responsibility to be certain that the cost and prices are reasonable and in line for the good's and services being provided.

SECTION 3. this ordinance is considered to be the "base" ordinance for the city and will require amendments as goods, services and employees change.

SECTION 4. this ordinance being necessary for the preservation of the peace, health and safety of the citizens of the City of Sheridan, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage.
