AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2021-14, THE 2022 ANNUAL BUDGET, GRANT COUNTY ARKANSAS.

WHEREAS, Appropriation Ordinance No. 2021-14 established the 2022 annual budget prior to quotes being finalized on some projects or the need even being known at the time of budget approval; and

WHEREAS, these projects include the courtroom remodel, courtroom automation, courtroom security, the recently purchased County Annex, airport improvements and automatic license plate recognition system.

THEREFORE, in order to meet the needs of our County this Court amends the 2022 annual budget.

Section 1. Budget Amendment.

This amendment to the 2022 Annual Budget, Grant County Arkansas appropriates the following expenditures:

Section 3. Revenue. This Ordinance shall also reflect unanticipated revenues in the 2022 Annual Budget, Grant County Arkansas for the following:

Airport Fund 3037
 \$403,383.00 Federal Government-FAA grants.
 \$288,000.00 State of Arkansas grants.
Court Security Grant Fund 3515
 \$ 20,000.00 State of Arkansas court security grant.

Section 4. Severability. If any provision of the Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provision or applications of the Ordinance which can be given effect without the invalid provisions or applications, and to this end, the provisions of this Ordinance are declared to be severable.

Section 5. Effective Date. This Ordinance shall be in force and shall take effect upon passage and approval.
