AN ORDINANCE FOR THE PURPOSE OF ANNEXING CERTAIN TERRITORY TO THE Y. AI CITY OF SHERIDAN, ARKANSAS, AND FOR OTHER PURPOSES.

WHEREAS, a petition was filed with the County Court of Grant County, Arkansas, signed by the owners, or agent therefor, of the hereinafter described lands asking that said territory be annexed to and made a part of the City of Sheridan, Arkansas; and,

WHEREAS, on the 1st day of November, 2022, the County Court of Grant County,

Arkansas, found that the petition was signed by the sole owner of the property, namely Winston

Land and Timber LLC; that the land was properly described; that an accurate map thereof was

made and filed; that the territory is contiguous to and adjoining the City of Sheridan, Arkansas,

and that no enclaves would be created by the proposed annexation; and

WHEREAS, the County Court found that the petition for annexation meets the statutory requirements of Ark. Code Ann. § 14-40-609;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SHERIDAN, ARKANSAS:

Section 1: That the following described land and territory is contiguous to and adjoining to the City of Sheridan, Arkansas, to-wit:

and that portion of the real property not currently in the City of Sheridan, is hereby accepted as part of and annexed to and made a part of the territory of the City of Sheridan, Arkansas.

Section 2. The said property is hereby declared to be a part of Ward 1 of the City of Sheridan, Arkansas.

Section 3. This ordinance being necessary for the preservation of the peace, health and safety of the citizens of the City of Sheridan, Arkansas, an emergency is hereby declared to exist; and this ordinance shall be in full force and effect from and after its passage.
