APPROPRIATION ORDINANCE NO. 2023 - 22 0

BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF GRANT STATE OF ARKANSAS; AN ORDINANCE TO BE ENTITLED:

"AN ORDINANCE ADOPTING THE SUPPLEMENTAL APPROPRIATIONS, TRANSFERS AND REVENUES TO THE 2022 ANNUAL GRANT COUNTY & BUDGET."

- **Section 1.** Supplemental Budget Adopted by Reference. The supplemental budget for calendar year 2022 identified as "Grant County Supplemental Budgets Year 2022" is hereby adopted by reference. A copy of said "supplemental budget" shall be filed in the Office of the County Clerk and shall be available for inspection and copying by any person during normal business hours.
- **Section 2.** Appropriations and Transfers. This Ordinance hereby appropriates for the following operating funds: County General-1000, ARPA Revenue Replacement-County Special Projects-1006, ARPA Revenue Replacement-Circuit/Chancery Div 2-1006, County Road-2000, Additional Motor Fuel Tax 2003, Circuit Court Automation-3002, County Library-3008, Solid Waste-3009, Emergency Medical Service Tax-Ambulance-3021, Criminal Justice-County Special Projects-3035, Airport-3037, County Law Library-3401, Emergency Medical Service 2017 Tax-3407.
- **Section 3.** <u>Purpose.</u> This Ordinance shall constitute appropriations for the purposes specified in said budgets for the calendar year 2022 subject only to revision or modification by the Quorum Court.
- **Section 4.** Expenditures. Said Grant County Supplemental Budgets for Year 2022 is hereby adopted by the Quorum Court and the County Judge is hereby authorized to approve expenditures consistent therewith as and when the same shall be needed and the Quorum Court further specifically appropriates and authorizes any previous expenditures consistent therewith made and approved by the County Judge for calendar year 2022.
- **Section 5.** Revenues. This Ordinance shall also reflect unanticipated revenues for the 2022 Annual Grant County Budget.
- **Section 6. Severability.** If any provision of the Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provision or applications of the Ordinance which can be given effect without the invalid provisions or applications, and to this end, the provisions of this Ordinance are declared to be severable.

Section 7. <u>Effective Date.</u> This Ordinance shall take effect upon passage and approval.
