AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2022-14, THE 2023 ANNUAL BUDGET, GRANT COUNTY ARKANSAS. GERALD HARRISON COUNTY & CIRCUIT CLERK GRANT COUNTY, AR

WHEREAS, it comes before this Court that there is a need to appropriate additional expenditures that have materialized since the adoption of said ordinance; and

WHEREAS, this Court determined that there was an error in the addition of the appropriation for the County General Fund, County Annex Office in the amount of \$5,000.00 for Building Materials & Repairs requiring an additional appropriation; and

WHEREAS, this Court determined that the salary appropriation for the County General Fund, Coroner Office was understated by \$3,500.00 requiring an additional appropriation; and

WHEREAS, Act 224 of 2022 authorized a stipend payment of \$5,000.00 to each eligible full-time law enforcement officer and the sheriff's department has employed a certified officer that meets the requirements of the Act. This Court desires the necessary expenditure for the payment to this one officer be appropriated. Said stipend shall not be incorporated into the base pay of the employee for future salary adjustments; and

WHEREAS, Act 786 of 2021 established a Department of Public Safety Equipment Grant Program and the sheriff department applied and received a grant through this program in the amount of \$21,347.00 to purchase equipment. Due to this being a new program grant no appropriations were done in the 2023 annual budget for this expenditure.

THEREFORE, the Court hereby amends the 2023 Annual Budget to reflect the following expenditures:

Section 1. Budget Amendment.

This amendment to the 2023 Annual Budget, Grant County Arkansas appropriates the following expenditures:
