BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF GRANT, STATE OF ARKANSAS:

AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2022-14, THE 2023 ANNUAL BUDGET, GRANT COUNTY ARKANSAS.

WHEREAS, it comes before this Court that there has been several unanticipated items have arisen that could impact the operation of county government that needs to be dealt with in this current budget year; and

WHEREAS, this Court finds the circumstances that has created the need for additional appropriations are the following: grant has been received for replacing the bridge on county road 2, security cameras for the courthouse are in constant need of repair, two central heating and air condition units at the office of emergency management are not operating and the replacement of patrol vehicles totaled in wrecks; and

WHEREAS, this Court determined that there was not significant appropriations in the 2023 annual budget to cover the above-mentioned expenses therefore requiring additional appropriations.

THEREFORE, the Court hereby amends the 2023 Annual Budget to reflect the following expenditures:

Section 1. Budget Amendment.

This amendment to the 2023 Annual Budget, Grant County Arkansas appropriates the following expenditures:

Section 2. Purpose. This Ordinance shall constitute new appropriations for the purposes specified for the calendar year 2023 subject only to revision or modification by the Quorum Court.

Section 3. Revenue. This Ordinance shall also reflect unanticipated revenues in the 2023 Annual Budget, Grant County Arkansas for the following:

Transfer from the County Road Reserve Fund to the County Road Fund \$ 335,000.00

Section 4. Severability. If any provision of the Ordinance or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provision or applications of the Ordinance which can be given effect without the invalid provisions or applications, and to this end, the provisions of this Ordinance are declared to be severable.

Section 5. <u>Effective Date.</u> Per Arkansas Code annotated §14-14-907 this Ordinance shall be effective immediately upon passage and approval.
