BE IT ENACTED BY THE QUORUM COURT OF THE COUNTY OF GRANT, STATE OF ARKANSAS, AN APPROPRIATION ORDINANCE TO BE ENTITLED:

AN ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE 2022-14, THE 2023 ANNUAL BUDGET, GRANT COUNTY ARKANSAS FOR BONUSES FOR ALL ELIGIBLE EMPLOYEES

WHEREAS, the Quorum Court of Grant County, AR, recognizes the value of the County employees and the dedication to the job that they demonstrate daily; and

WHEREAS, the Quorum Court wishes to recognize that dedication by providing a bonus for the year 2023.

NOW THEREFORE, BE IT ORDAINED BY THE QUORUM COURT OF GRANT COUNTY, ARKANSAS

SECTION 1. That it hereby approves bonus pay for the year 2023 for County employees currently employed by Grant County as of December 18, 2023.

SECTION 2. Each eligible Grant County employee classified as full-time and currently employed shall be paid a one-time bonus payment of five hundred dollars (\$500.00), from which all applicable payroll deductions shall be deducted.

SECTION 3. Each eligible Grant County employee classified as part-time and currently employed shall be paid a one-time bonus payment of two hundred fifty dollars (\$250.00), from which all applicable payroll deductions shall be deducted.

SECTION 4. Ordinance No. 2022-14, the "2023 Annual Budget, Grant County Arkansas", is hereby amended and the respective sums shall be expended from the appropriate fund and allocated to the expenditure codes in the amount set forth in the attachment hereby adopted by reference and so titled "2023 Bonus Pay Appropriation".

SECTION 5. This Ordinance shall also reflect unanticipated revenues in the 2023 Annual Budget, Grant County Arkansas for the following:

County General Fund 1000
\$ 35,500.00 Additional State turnback.
County Road Fund 2000
\$ 15,500.00 Additional State turnback.
Victim Witness Fund 3025
\$ 1,000.00 Additional victim/witness coordinator reimbursement.

SECTION 6. If any of the provisions of this ordinance or the application thereof to any person or circumstances shall be held invalid, such invalidity shall not affect the other provisions or application, and to this end, the provisions of this Ordinance are declared severable.

SECTION 7. Per Arkansas Code annotated §14-14-907 this Ordinance shall be effective immediately upon passage and approval.
