**A RESOLUTION TO PROVIDE FOR THE INTERIM FILLING OF A VACANCY  
IN THE OFFICE OF GRANT COUNTY SHERIFF DURING TIMES  
OF EMERGENCY AND FOR OTHER PURPOSES**

WHEREAS, A.C.A. SECTION 14-14-1310(c)(2) provides for the interim filling of a vacancy in the Office of Sheriff during times of emergency declared pursuant to A.C.A. Section 12-75-107 or 12-75-108; and

WHEREAS, the Sheriff has created a policy statement, to which he has affixed his signature, designating three persons in succession to fill a vacancy in the Office of Sheriff, in the event of a vacancy during a declared emergency, on an interim basis until any disability of the Sheriff is abated or until such vacancy is otherwise filled by law.

NOW THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF GRANT COUNTY, ARKANSAS THAT:

The attached policy statement of the Sheriff providing for succession in the event of a vacancy in the Office of Grant County Sheriff during a declared emergency is hereby adopted.



**POLICY ESTABLISHING EMERGENCY VACANCY LINE OF SUCCESSION FOR THE GRANT COUNTY SHERIFF**

I, David (Pete) Roberts, Grant County Sheriff, acting under the authority vested in me by law and pursuant to A.C.A. Section 14-14-1310, do hereby order and direct as follows:

WHEREAS, A.C.A. Section 14-14-1310 requires that during an emergency or circumstances that Warrant a declaration of any emergency, a vacancy in the Office of County Sheriff due to death, or disability, to the degree of inability to perform the duties of office, shall be temporarily filled by a policy statement of the Sheriff issued prior to the incapacity of the Sheriff, designating three (3) persons in succession to fill the vacancy of the Office of County Sheriff on an interim basis until such time as the vacancy is filled as provided by law or the disability of the County Sheriff is abated.

THEREFORE, the line of succession for the Grant County Sheriff is hereby established in the order of succession as follows:

1. Chief Deputy
2. Lieutenant
3. Sergeant

A copy of this policy statement shall be fixed in the office of the Grant County Clerk and a file-marked copy shall be provided to the Grant County Quorum Court and the Director of the Arkansas Department of Emergency Management.
