

Next on the agenda: Phase Two (II) Justice Complex Update. Judge Randy Pruitt stated, bids came in too high, they ranged from \$598,500.00 to over \$700,000.00 and all bids have been rejected. The next step is to do value engineering and see about getting the cost down. We will go back to the table, run it in the newspaper again, and see where we can shave off some of the extras to get a more reasonable bid.
